Directions to Phil Foster Park

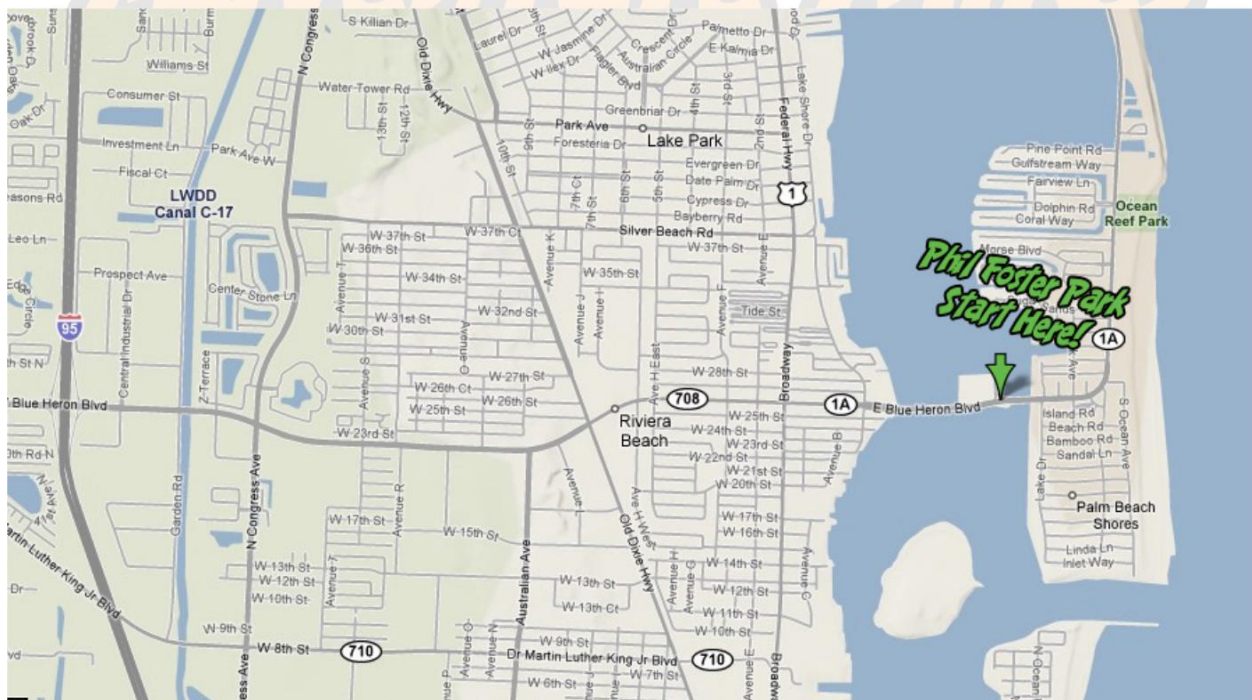
IMPORTANT: The adventure begins at 9AM so plan to be early so you don't miss the boat.
